#### WESTERN HIGH SCHOOL NEW COURSE OFFERINGS 2018-2019

I am requesting the approval for a four (4) new curricular options for the 2018-2019 school year. We feel strongly the addition of these courses will further enhance the educational opportunities for our students.

AP PHYSICS 1: ALGEBRA-BASED (L) 3080 (PHYS 1 AP) — <u>REPLACING</u> currently offered Honors Physics AP Physics1 is a course based on the content established and copyrighted by the College Board. The course is not intended to be used as a dual credit course. AP Physics 1: Algebra-based is equivalent to a first-semester college course in algebra-based physics. The course covers Newtonian mechanics (including rotational dynamics and angular momentum); work, energy, and power; mechanical waves and sound. It will also introduce electric circuits.

- Recommended Grade Level: 10, 11
- Recommended Prerequisite: Algebra I or Integrated Mathematics I
- Credits: 2 semester course, 1 credit per semester
- Counts as a Science Course for all diplomas
- Qualifies as a quantitative reasoning course

#### AP PHYSICS 2: ALGEBRA-BASED (L) 3081 (PHYS 2 AP) - New 2<sup>nd</sup> year physics offering

AP Physics2 is a course based on the content established and copyrighted by the College Board. The course is not intended to be used as a dual credit course. AP Physics 2: Algebra-based is equivalent to a second-semester college course in algebra-based physics. The course covers fluid mechanics; thermodynamics; electricity and magnetism; optics; atomic and nuclear physics.

- Recommended Grade Level: 11, 12
- Recommended Prerequisite: AP Physics 1: Algebra-based
- Credits: 2 semester course, 1 credit per semester
- Counts as a Science Course for all diplomas
- Qualifies as a quantitative reasoning course



#### INDIANA STUDIES 1518 (IN STUDIES) - Required Offering\*

Indiana Studies is an integrated course that compares and contrasts state and national developments in the areas of politics, economics, history, and culture. The course uses Indiana history as a basis for understanding current policies, practices, and state legislative procedures. It also includes the study of state and national constitutions from a historical perspective and as a current foundation of government. Examination of individual leaders and their roles in a democratic society will be included and student will examine the participation of citizens in the political process. Selections from Indiana arts and literature may also be analyzed for insights into historical events and cultural expressions.

- Recommended Grade Level: none
- · Recommended Prerequisites: none
- Credits: 1 semester course, 1 credit per semester
- · Counts as an Elective for all diplomas

#### ETHNIC STUDIES 1516 (ETH STUDIES) - Required Offering\*

Ethnic Studies provides opportunities to broaden students' perspectives concerning lifestyles and cultural patterns of ethnic groups in the United States. This course will either focus on a particular ethnic group or groups, or use a comparative approach to the study of patterns of cultural development, immigration, and assimilation, as well as the contributions of specific ethnic or cultural groups. The course may also include analysis of the political impact of ethnic diversity in the United States.

- Recommended Grade Level: none
- Recommended Prerequisites: none
- Credits: 1 semester course, 1 credit
- Counts as an Elective for all diplomas

\*Indiana Studies and Ethnic Studies were mandated by legislation in the summer of 2017. We offered the courses for 2017-2018, but it was way past the completion of scheduling so there was little to no student interest or enrollment.

The addition of these curricular options should not, at this time, result in additional staffing. Resources such as textbooks may be needed, but the emphasis will be to delay any textbook purchase until the adoption year. Student materials, supplies, and equipment will be purchased through departmental supply funds and appropriate capital fund allocations.

These courses will allow for students to continue to work toward their Core 40, Academic Honors Diploma, or Technical Honors Diploma and pursue coursework that supports their interests. We believe these new course offerings are necessary to broaden the opportunities for our students and will continue to move Western High School toward new levels of success. We feel these courses will strengthen our curricular offerings and provide additional opportunity to better prepare WHS students for their future. Thank you for your consideration.

After discussion with Rachael Stewart, Western Nursing Coordinator, there has been a revision to all Student Handbooks regarding a 24 hour waiting time, before returning to school, after a student experiences a fever and/or vomiting during an illness.

The following revision will appear in the Student Handbook under Health Services:

If a student has a fever of 100 degrees Fahrenheit or greater, and/or vomits due to an illness, the student will be sent home from school, or the student should be kept home from school if prior to school hours. Students may return to school after 24 hours have passed with a normal temperature without the use of fever-reducing medications, and/or no vomiting. The 24 hour policy is based off of the CDC (Center for Disease Control) recommendations and guidelines for schools. Parents must call in illnesses to office personnel, or a written note should be sent with student when returning to school.
