4. **Director of Exceptional Learners and Testing:** Mrs. Stranahan submitted the following report:

Important Items from Wednesday April 15, 2015 – Tuesday, May 12, 2015

- ❖ Conducted a total of 44 case conferences
- ❖ ISTEP+ testing has been completed at WIS and WMS
 - 3rd, 4th, 6th, 7th, and all students with the screen reader accommodation in grades 5th and 8th took the paper/pencil version
 - 5th and 8th grade took the assessment online
 - There were some minor issues with tests freezing. Computers affected had to be restarted, but all work was saved once restarted so the students could continue from where they were working.

- ❖ ECA testing for each Biology, English 10, and Algebra I is underway at WHS. Once again, there have been some minor issues associated with computers freezing up due to their new testing platform. There was one instance where a student lost the essay he was writing and had to complete it again. There was another instance in which a student's test did not save. The tech team was able to pull the cache files and the testing vendor was able to recover the test.

5. Superintendent: Mr. McCracken submitted the following report:

1. Summer School Update

We are in the process of finalizing the numbers for Summer School. Western again will host Summer School for the Life Skills Program for Eastern, Maconaquah, Northwestern, Taylor, Tipton, Tri-Central and Western students. Life Skills Jump Start will only include Northwestern, Taylor, Tipton, Tri-Central and Western since Eastern and Maconaquah have earlier start dates.

As in the past, I will bring staff recommendations to you in June for your approval once we have a final count of students attending and classes to be offered. We need a minimum of 15 students in classes that qualify for reimbursement.

2. Building Construction Bonds – We have the following bonds for our construction projects through the Western School Building Corporation:

- \$3,340,000 First Mortgage Bonds, Series 2015A
- \$2,000,000 First Mortgage Bonds, Series 2015B
- \$2,000,000 First Mortgage Bonds, Series 2015C

Closing was on May 12, 2015, with the purchaser of the bonds being Huntington Public Capital Corporation.

Total Bond proceeds are \$7,688,225 (total principal amount of Bonds plus Bond premium in the amount of \$375,750 less placement agent fee in the amount of \$27,525).

In addition, we have a General Obligation Bond for \$1,900,000 that will also be used for the projects.

When we began this process, we shared with the community that we would complete the projects and structure our debt so that we would not raise our debt service levy above where it was in 2014 (\$2,841,678). We actually focused on the amount \$2,826,000 as we progressed through planning process for the projects. The attached debt service picture which incorporates the actual amounts of all debt and bonds shows that other than in 2016, we will be at our levy target of \$2,826,000. In 2016, we will actually be slightly over our target but will use Rainy Day Funds to off-set the levy so that we keep our pledge to our community. In 2015, our debt service levy actually decreased to \$1,923,129 which is the result of one debt falling off before the three bonds above come on.
